4 CUMULATIVE SCHEMES

4.1 In relation to cumulative effects, the Scoping Direction issued by Planning and Environment Decisions Wales (PEDW) on 6th May 2022 states:

“The applicant is advised to ensure that any study also includes the impacts, if any, generated from DNS/3272053 Tywn Hywel Wind Farm, DNS/3280378 Mynydd y Glyn wind farm and DNS/3266623 Cwm Ifor Solar as well as any other large-scale developments that may come forward [whilst compiling the EIA].

4.2 No further large-scale developments have been identified during the EIA process and therefore, this ES considers the following cumulative schemes:

- Cwm Ifor Solar (DNS/3266623);
- Tywn Hywel Wind Farm (DNS/3272053); and
- Mynydd y Glyn Wind Farm (DNS/3280378).

Cwm Ifor Solar

4.3 The Cwm Ifor Solar Farm is a proposal to develop a 15MW solar farm to the north of Caerphilly town centre. The proposal is being progressed by Caerphilly County Borough Council (CCBC) and is currently in the pre-application stage.

4.4 A full business case is expected to be presented to CCBC’s Cabinet in 2022 for funding approval in 2022.

4.5 At the time of writing of this ES, a Notice of Intention to Submit a DNS Application had not been submitted to PEDW although a Screening Direction had been issued by PEDW on 30th March 2022.

Tywn Hywel Wind Farm

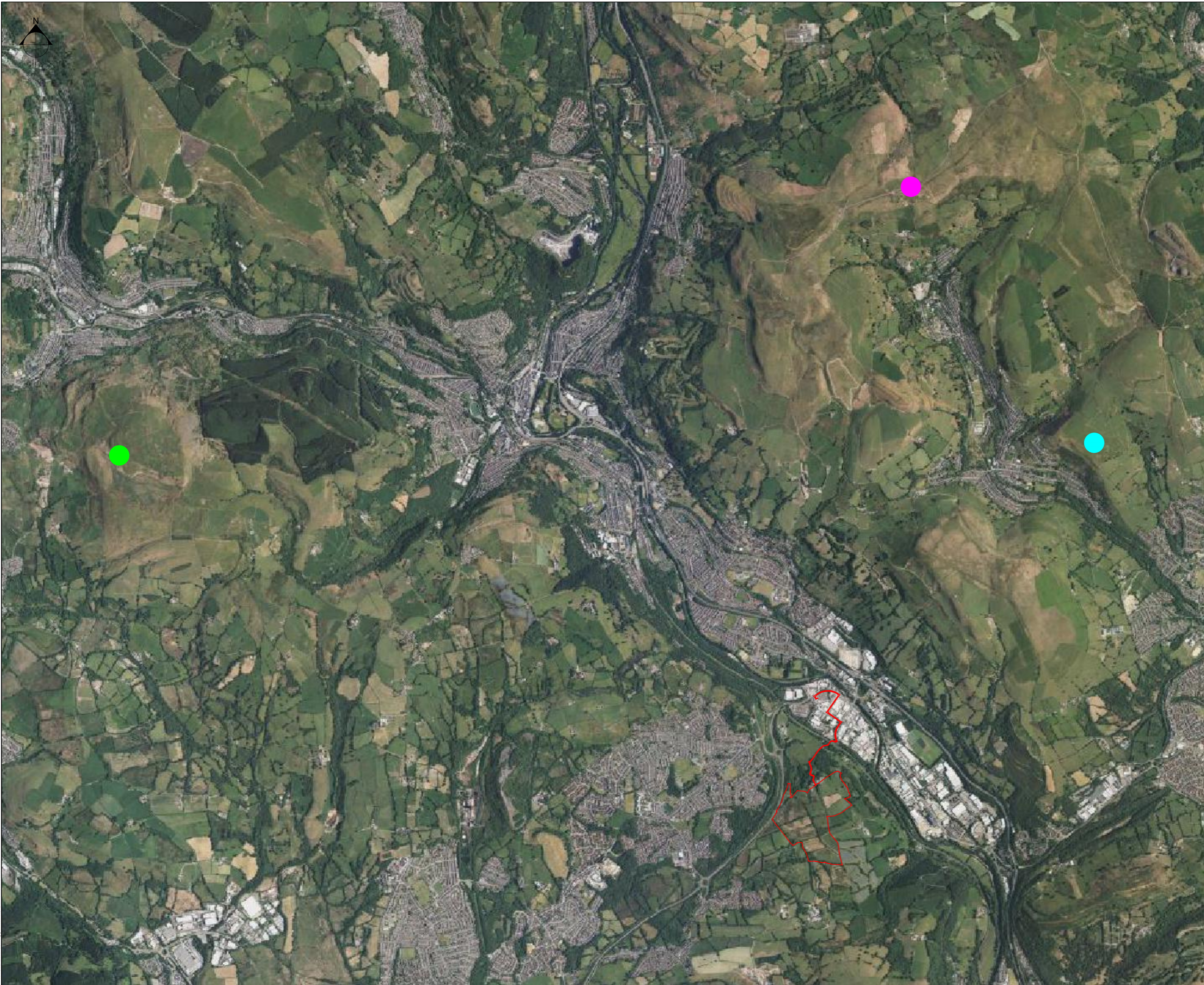
4.6 The Tywn Hywel Wind Farm is a proposal for erection and operation of 20 wind turbines at Eglwysilan Common, land north of Senghenydd, Caerphilly. The proposal is being progressed by developer Bute Energy and is currently in the pre-application stage.

4.7 At the time of writing of this ES, a Notice of Intention to Submit a DNS Application had not been submitted to PEDW although a Scoping Direction had been issued by PEDW on 22nd October 2021.

Mynydd y Glyn Wind Farm

4.8 The Mynydd y Glyn Wind Farm is a proposal for a wind farm of up to seven turbines and ancillary works at Land to the East of Trebanog, Rhondda Cynon Taf. The proposal is being progressed by developer Pennant Walters Ltd and is currently in the pre-application stage.

4.9 At the time of writing of this ES, a Notice of Intention to Submit a DNS Application had not been submitted to PEDW although a Scoping Direction had been issued by PEDW on 1st December 2021.
